It is further noted that "Paranormal Truth Seekers Expo" is utilized throughout this document as the event, which Awakening Moments Center is sponsoring in conjunction with Paranormal Truth Seekers.

The receipt by Paranormal Truth Seekers Expo of your signed contract, accompanied by payment in full, will constitute an application for exhibitor with Paranormal Truth Seekers Expo. (All applications received will be reviewed before participation is confirmed since this is a juried event.

Exhibitor on the application form shall not transfer, barter, sell, sublet, or assign entitlement (including but not limited to exhibit space during the event) in whole or in part without written notice to and approval from Paranormal Truth Seekers Expo.

Cancellations of Agreement The Exhibitor shall have the right to cancel this Agreement at any time by written notice to Paranormal Truth Seekers Expo. In the event of such cancellation received up to 200 days before the event, Paranormal Truth Seekers Expo shall refund full exhibitors fees less a pro rata amount equivalent to advertising dollars received from logo placement in printed publications. Paranormal Truth Seekers Expo shall refund 50% of exhibitor fees on cancellations received 180 days before the event, less a pro-rata amount of equivalent advertising dollars received from logo placement in printed publications.
